The defendant while in the lawful jurisdiction of Titusville, did commit the offense of aggravated battery by actually and intentionally striking the victims against their will.

The defendant knowingly and intentionally reversed his vehicle bearing FL tag # BG14EE into victim one, striking the victim in the chest and stomach area. He then drove his vehicle forward and reversed it again, this time striking victim one and victim two with the vehicle. Victim one stated that he has history with the defendant and that the defendant has done this to him before in the past. I attempted to speak with the defendant through the window of his residence and he refused to speak about the incident and refused to step outside of his residence. This charge is supported by sworn audio/video-recorded statements by Sarina.
